AN ORDINANCE TO ADOPT THE CODE OF ORDINANCES FOR THE CITY OF FARMINGTON, IOWA

BE IT ENACTED by the Council of the City of Farmington, Iowa:

SECTION 1 Purpose. The purpose of this Ordinance is to codify and compile a Code of Ordinances for the City of Farmington, Iowa, containing all of the City Ordinances in effect except grade ordinances, bond ordinances, zoning ordinances and ordinances vacating streets and alleys.

SECTION 2 City Codes Provisions. The City Code of Farmington, Iowa shall consist of the following existing Ordinances which shall be renumbered as stated below. (All Ordinances are either no changes, revised, or amended to current conditions, or new Ordinances effective by their publication in loose leaf copies available for inspection in the Office of City Clerk.)

Ordinance No. 28 - An Ordinance to License and to Regulate Peddlers, Solicitors and Transient Merchants and to Provide Penalties for Violations

Ordinance No. 29 - An Ordinance Relating to the Posting Bills or Distributing Hand or Other Bills or Papers in the City of Farmington, Van Buren County, Iowa

Ordinance No. 30 - An Ordinance Establishing a Curfew for Minors and Providing Penalties for Violations

Ordinance No. 31 - An Ordinance Defining and Prohibiting Offenses Against the Peace, Safety, Health, Welfare, Comfort, and Convenience of the City and Its Residents and Providing Penalties for Violations

Ordinance No. 32 - An Ordinance Relating to Weeds, Thistles, and Noxious Plants

Ordinance No. 33 - An Ordinance Regulating Mobile Homes and Mobile Home Parks Within the Corporate Limits of the City of Farmington and Providing Penalties for Violations

Ordinance No. 34 - An Ordinance to Provide a Specified Method for Construction of Sidewalks and to Provide for the Repair and Care of Sidewalks and Providing Penalties for Violations

Ordinance No. 35 - An Ordinance Regarding the Planting, Care, Trimming and Removal of Trees and Providing Penalties

Ordinance No. 36 - An Ordinance Establishing Fire Limits, Regulating the Erection of Buildings Therein, and Providing for the Removal of Buildings Erected in Violation Thereof

Ordinance No. 37 - An Ordinance Regulating and Restricting the Location and Construction of Buildings and Structures in the City of Farmington, Iowa, and Providing Penalties for Violations

Ordinance No. 38 - An Ordinance Regulating and Establishing the Distance from the Lot Line that the Curb Shall be Placed on the Different Streets in the City of Farmington, Iowa

SECTION 3 Repealer. All Ordinances or parts of Ordinances in conflict with the provisions of this Ordinance are hereby repealed. These are: none.

SECTION 4 Severability clause. If any section, provision or part of this Ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the Ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

SECTION 5 When effective. This Ordinance shall be in effect after its final passage, approval and publication as provided by law.
