The Farmington City Council met at Special Meeting on Monday, March 25, 2024 at Farmington City Hall. Mayor Janet Browning called the meeting to order at 6:45 P.M. Council members present for roll call were Kerby Fry, Stephen Gobush, Rick Burkett and Tim Halbrook. Taylor Diephuis was absent. Also present during the meeting were City Clerk, Megan Muse and Deputy Clerk, Becky Fry. Motion was made by Burkett to approve the Agenda, seconded by Halbrook. Motion carried 4-0.

RESOLUTION 2024-05 Resolution Setting Public Hearing on FY 2024-2025 Budget. This Resolution sets a Public Hearing on the proposed FY 2024-2025 Budget for April 8, 2024 at 6:00 PM at Farmington City Hall, 203 Elm St., Farmington, IA 52626. Halbrook made a motion to approve Resolution 2024-05 and Gobush seconded the motion. Roll Call: Fry-AYE; Gobush-AYE; Burkett-AYE; Halbrook-AYE. Motion carried 4-0 (Diephuis absent).

RESOLUTION 2024-06 A Resolution Proposing the Granting of 99 Year Easements on Property Owned by Farmington, Iowa in Van Buren County, Iowa. This Resolution sets a Public Hearing for the purpose of considering the granting of 99 year easements on property currently leased for cell towers for May 13, 2024 at 6:00 PM. Fry made a motion to approve Resolution 2024-06 and Gobush seconded the motion. Roll Call: Fry-AYE; Gobush-AYE; Burkett-AYE; Halbrook-AYE. Motion carried 4-0 (Diephuis absent).

After review of Amendment to Ordinance 24, an Ordinance Regulating Traffic Upon and Use of the Streets and Providing Penalties Thereof in Addition to Controlled Access Facilities on the Primary Road Highway #2 and Streets Within the City of Farmington, Iowa, Gobush made a motion to approve the first reading of said Ordinance Amendment for passage, to waive the second reading and to have the third and final reading on April 8, 2024. Burkett seconded the motion. Roll Call: Fry-AYE; Gobush-AYE; Burkett-AYE; Halbrook-AYE. Motion carried 4-0 (Diephuis absent).

Council members discussed various building and ditching issues in the City.
